**Pierre Mongin will be appointed Executive Vice President, General Secretary,  
on 1 July 2015**

Pierre Mongin, 60 years old, Chairman and Chief Executive Officer of the RATP Group, graduated from the *Institut d'études politiques de Paris* with a master's degree in economics and studied at the *Ecole nationale d'administration* (ENA). He will join GDF SUEZ on 1 May 2015 as Executive Vice President. He will be appointed General Secretary on 1 July 2015, replacing Alain Chaigneau, who, wishing to claim his pension rights, will be appointed Special Advisor to Gérard Mestrallet on the same date.
